



## Stability Assessment of Compounded Benzocaine 20%, Lidocaine 6% and Tetracaine 4% in Medisca VersaPro™ Cream Base

The physical, chemical, and microbiological stability of Benzocaine 20%, Lidocaine 6% and Tetracaine 4% compounded in VersaPro Cream Base were evaluated over time. The formulation was packaged in tightly-closed, light resistant, plastic containers and stored at controlled room temperature (25 °C) for the duration of the study. Physicochemical characteristics were analyzed at predetermined time points (0, 30, 60, 90, 120, 150 and 180 days) and the formula tested had the organoleptic properties inspected, the pH measured, and the API concentrations assayed using a validated, stability-indicating HPLC-UV method. The antimicrobial preservative effectiveness was also tested using a validated method according to USP <51>.

The results showed that the concentration of the Benzocaine, Lidocaine and Tetracaine formulation remained within USP specification (90 to 110%) for at least 180 days at the tested conditions (*Table 1*). No significant changes in organoleptic properties or pH were observed. Antimicrobial preservative effectiveness also met USP <51> requirements for the formulation (*Table 2*). In conclusion, Benzocaine 20%, Lidocaine 6% and Tetracaine 4% in VersaPro Cream Base was found to be physically, chemically and microbiologically stable for up to 180 days at the tested conditions. Therefore, an extended beyond-use date of 180 days may be assigned to this formulation if the same vehicle and conditions are respected.
