#### **DIRECTIONS OF USE:**

To use as a One-Step Cleaner/Disinfectant, pre-clean if area is heavily soiled, perhaps after a spill or maintenance. Apply solution by using a cleanroom wipe or mop to hard, non-porous surfaces. All surfaces must remain wet for 1 minute. Use a 5 minute contact time for TB and a 10 minute contact time for fungi. Even though PREempt leaves little surface residue, best practice is to wipe surfaces dry after the contact time.
