**Ingredients:** Water, Glycerin, Natural and Artificial Flavors, Potassium Sorbate

**BSE:** the product listed above is not animal-derived, contains **no ingredients of animal origin**, and is free from Transmissible Spongiform Encephalopathy (TSE) and Bovine Spongiform Encephalopathy (BSE).
